\*\*In addition to tuition, each student is assessed for technology, pottery, Home and School, and classroom fees. The supply list included in the summer packet will designate those specific charges. These fees are variable, but typically fall within the \$132.00-\$165.00 range. There are additional fees for extra-curricular activities.

The total cost of educating a child at St. Vincent de Paul is \$5,450 per year. Tuition covers approximately 65% of the school's cost. Additional funds are raised through fundraising. The remaining costs are supplemented by parish investment. The Parish Investment and Tuition shown above applies to Catholics registered with a parish community (St Vincent de Paul or any other Catholic Parish). The Parish Investment is reduced by \$500 for families who are not registered at a Catholic Parish, resulting in an additional \$500 of tuition per student.
